

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.nationwidelendingdirect.com and Nationwide Lending Direct and governs data collection and usage. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Nationwide Lending Direct may collect personally identifiable information, such as your:
